Skip-A-Payment Rules

- A processing fee of \$25.00 per loan will be deducted from your account. If you do not have \$25.00 in your account, please mail a check for \$25.00 with your Holiday Skip-A-Payment request.
- Loans cannot be past due at the time of request. All lines of credit, real estate
 mortgages, home equity loans, business loans, credit cards, and overdraft
 protection loans are excluded from this promotion. Application and approval
 is required for all skipped payments. All applications are subject to the Credit
 Union's final approval.
- Applications should be received at least ten business days prior to loan due date. Interest will continue to accrue on unpaid balances through skipped payment period.
